Worship at General Conference

Affirmation will provide a special worship service during General Conference. The service will be during the noon lunch hour Friday, April 19. The location is still being finalized.

Bishop Fritz Mutti, of the Kansas Annual Conference, will be our preacher.

If you can't be with us in person, please keep us in your prayers during this time.

General Conference Advocacy

Affirmation has adopted a platform entitled "And grace will lead us home." This last line from a verse of Amazing Grace evokes the "dangers, toils and snares" that have been our experience as lesbians, gay, bisexual and transexual people. We've known insults and rejection, loss of jobs and loss of children, denial of rights and evictions, bashings and murder. From the Appalacian Trail to Texas and Oregon, our people are being murdered because of their sexual orientation. The United Methodist Church must speak out against this.

People from Affirmation have helped plan a General Conference event to witness to the long-standing committment of The United Methodist Church to human rights. Affirmation will call upon General Conference to honor that commitment by amending the Social Principles Statement in three ways:

1. Add the sentence "We support the basic rights of all persons to equal access to education, housing, employment, medical care, legal redress for grievances and physical protection," to the opening statement of Paragraph 72: The Social Community;

2. Add a new section to Paragraph 72: Rights Regardless of Sexual Orientation or Gender Identity;

3. Amend Paragraph 76, Our Social Creed, to include sexual orientation.

In addition, we call upon The United Methodist Church to adopt a resolution entitled: "Opposition to Discrimination Against Gay and Lesbian People."



As before, we will coordinate our lobbying efforts with the Methodist Federation for Social Action. With them, we believe it is past time for the Church to remove all offensive and demeaning heterosexist passages and rules from the Discipline. We will certainly be forward to point out the contradictions between celebrating a commitment to human rights and retaining legislation that treats people quite differently based on the status of their sexual orientation. Nonetheless, our first line of advocacy is this: In a time when people are being killed because of their sexual orientation the Church must speak clearly and forcefully to defend human rights regardless of sexual orientation.

Come Home

On November 11, Jeanne Knepper, speaking as co-spokesperson for Affirmation, addressed the United Methodist Pre-1996 General Conference Press briefing with these remarks:

It is an amazing thing, to be standing here to address you, on several levels. One, you're still here. It's been a long time with a lot of information, but you're here, loyal and responsible to the end, showing your love for this church of ours by your faithful steadi-

ness. Second, Affirmation's still here, still living out our loyal, if difficutl, relationship with the church that is our home.

Affirmation will be in Denver for General Conference. As before, we'll publish a daily newsletter, host worship and celebration, and create a space for information and retreat.

As before, we'll ask this church we share to remove passages that demean or discriminate from its policies and social principles. We do not ask this naively or without knowledge of what has gone before.

Yet, we come to you with courage, hope and confidence, not in ourselves or in our own powers of persuasion. No, we come to you confident in the power of God's grace. That is our sole platform: Grace Will Lead Us Home.

You know the verse, from that most loved hymn:

"Through many dangers, toils and snares,

I have already come; 'tis grace hath brought me safe thus far, and grace will lead me

and grace will lead me home."

We believe that it's tir

We believe that it's time for The United Methodist Church to come home.

We've been wandering in a wilderness of alienation, judgment, and estrangement too long: come home.

We've devoted precious human resources to defending the gates against people who seek to answer God's call: come home.

We've been quarreling over the jots and tittles of definitions and disciplinary paragraphs while a great world waits for the words of grace: come home.

Beloved colleagues, come home.

Reconciling Congregations Surpass 100

(Dec. 7, 1995)--The Reconciling Congregation Program reached a milestone in November as Pacific Beach U.M. Church in San Diego became the 100th United Methodist congregation to publicly welcome all persons, regardless of sexual orientation. This national movement. begun in 1984, now encompasses 103 ...a record year

Reconciling Congregations. In addi-11 campus ministries have declared themselves

ciling.

This has been a record year for the program with 18 Reconciling Congregations and 6 new Reconciling Campus Ministries so far in "The tide is turning in The United Methodist Church," observed program coordinator Mark Bowman. "Several hundred more churches and campus ministries are considering becoming 'reconciling.' More and more United Methodists recognize that gay and lesbian persons and their families are driven away from churches and want to invite them in instead."

A new program initiative, the Open the Doors campaign, directs this message of welcome and hospitality to The United Methodist Church's General Conference in April. 1996. This 1,000-member assembly, which meets every four years to write church law, has adopted unwelcoming policies toward gay and lesbian persons and their families in the past. Reconciling Congregations are calling on the General Conference to "open the doors" of United Methodist churches to all persons.

More than 2,000 indi-

viduals have enrolled as Reconciling United Methodists so far in the campaign, toward a goal of 9,600 by April, 1996. 'Knock-Ins"--held in October in New York, Atlanta, Chicago, Denver, Fort Worth and San Francisco--trained 160 activists to carry out campaign activities in their communities. Persons are meeting with General Conference delegates urging them to advocate church policies to end discrimination against les-

bian and gay persons and their families.

"Open the Doors for the program... is unleashing a ground swell in the church." noted coordicampaign Preston.

nator James "Reconciling United Methodist cards and inquiries arrive every day from dozens of persons who've just heard about the campaign. Stories of church doors being closed upon gay, lesbian and bisexual United Methodists and their families abound. Our message is, quite simply, that Jesus calls us to 'open the doors."







Affirmation Council Meeting in Atlanta

General Conference was heavy on the agenda at the Affirmation Council meeting January 13-16, 1996, in Atlanta. The Witness Committee arranged for Affirmation to share space at General Conference with three other groups: Methodists for Social Action (MFSA); Reconciling Congregation Program (RCP); and the Yellow Ribbon (women's caucus).

Affirmation will hold a Pre-General Conference event, Saturday noon through Sunday noon, April 13-14, to which supporters are invited. The event will brief people on issues and strategies for General Conference. (Check out the article and registration form elsewhere in this newsletter.) A worship service and evening celebration banquet with awards will round out our presence at General Conference.

The Evangelism Committee is coordinating Affirmation's daily newsletter for General Conference. It will be handed out to delegates to educate folks and address critical issues. Copies will be made available by mail for a fee. Local press contacts are being made in advance so our message will be loud and clear.



Beyond General Conference, the Affirmation Program Committee is working hard to plan the fall gathering which will be held in **New York City**, October 18-20, 1996. This is one week later than the usual Columbus Day weekend because there is a major display of the AIDS Memorial Quilt in Washington, D.C. over Columbus Day weekend. People may want to make an East Coast week of it by going to D.C. one weekend and move on to NYC sometime during the week to attend the Affirmation meeting.

Information on NYC sightseeing and inexpensive housing arrangements such as a Youth Hostel and other options will be made available before the event. Set you vacation dates NOW!

Several at-large members of the Council have finished their tenure as of the April meeting so the Nomination Committee is developing a slate for action at the spring meeting. Ellie Charlton has decided to step down a year ahead of schedule and John Calhoun has agreed to serve as treasurer.

The Stewardship Committee reported that finances are in the black although General Conference expenses will be high and donations are needed to meet the need. Greg Wise, part-time paid staff person for Affirmation resigned. The Council accepted the offer of Paul Thompson to serve as a volunteer staff person for Affirmation.

The Council spent significant time reflecting on the work and movement of Affirmation nation-wide. Eight years have passed since Affirmation did a long-range planning process. The Council will be doing an assessment over the coming months and a report will be brought in at the fall meeting.

The Evangelism Committee will be developing a flyer with articles that can be reproduced in local group newsletters. Newsletter editors, watch for this!

The Council celebrated the birthday of Martin Luther King, Jr. and grieved the murders of Michelle Abdill and Roxanne Ellis, lesbian women who were United Methodist members of a Reconciling Congregation in Oregon. ∇

UM Clergywoman Says She Will Stop Speaking on Homosexuality

UMNS) -- A United Methodist clergywoman who publicly revealed herself to be a lesbian last

summer said she will decline any speaking engagements

about the issue of homosexuality.

The Rev. Jeanne Audrey Powers, associate general secretary with the UM Commission on Christian Unity and Interreligious Concerns, explained she is trying to avoid any perceived conflict with denominational regulations.

In a formal statement, Powers said she considered the option of taking early retirement. "However, because I have been vocationally committed to the unity of the church and because I care deeply about the legislation being sub-

mitted by the general commission to General Conference, I have decided to limit my public speaking through General Conference to other issues on the ecumenical and interreligious agenda," she said.

bruce Hobbins, the commission's general secretary, issued a short letter about her state-

ment on Jan 3. He pointed out that he and Bishop William Boyd Grove of Albany, N.Y., the commission's president, "have defended her right to tell the truth about her sexual orientation."

Leaders of the denomination's General Council on Finance and Administration (GCFA) have affirmed the commission's belief that Powers' revelation does not put it in violation of the *Book of Discipline*.

Paragraph 906.12 of the Discipline states "that no

board, agency, committee, commission or council shall give United Methodist funds to any 'gay' caucus or group or otherwise use such funds to promote the acceptance of homosexulaity."

However, GCFA officials "did raise concerns" that continued pulblic discussion about homosexuality by Powers might be viewed as promotion of such acceptance, Robbins said.

The clergywoman pointed out in her statement that "what consitutes 'promotion,' which has plagued the church for two decades, continues to trouble our denomination." ∇

From the Editor's Corner

From Chaos to Reconconciliation

John Linscheid starts off an article in a recent issue of *The Other Side* ("Creating Companionship," September-October 1995) "I suppose it was James Weldon Johnson's poem 'God's Trombones' that first suggested to me that the void of chaos might be identified with God's loneliness. 'I'm lonely--I'll make me a world.""

Did God create our world because of loneliness? And did God create homosexuals to help fill that loney void? Mr. Linscheid's article is a reflection on the Creation Story as found in Genesis, and he is talking about the void and the darkness which existed before God started out on his great adventure. He goes on to say "We, too, who are a queer people, have hovered in darkness—alone." He relates God's loneliness to the loneliness felt by so many homosexuals.

One of the great themes of the Creation Story is that everything God created is good: "God saw everything that God had made, and indeed, it was very good" (1:31). And, of course, this includes homosexuals as part of God's good creation.

There is an old man who once thought (because of a "vision") that he was created homosexual because God wanted him to bring other homosexuals to Jesus Christ. Following the argument that Jesus' main purpose is to reconcile the world to God, this man now realizes that God has created all homosexuals for some very special reasons. Perhaps the greatest of these is to reconcile the world to God. Not that this is an exclusive task to be performed by homosexuals only. Nor is it the only reason that God created a certain number of men and women homosexuals. No. But perhaps it is the most important task for us, as members of Affirmation, to carry out. Perhaps it is because God has made homosexuals capable of "tuning in" to God easier than for most heterosexuals. The homosexual's "spiritual hearing" is more acute.

According to Genesis, God created the world out of chaos. And all that God created God proclaimed "good." But there are times when we, the inhabitants of God's good creation, think that the chaos has never been overcome. It is interesting to note that in the same issue of *The Other Side* there is an article entitled "The World According to

MTV: Music videos and the aesthetics of chaos.

Well, with MTV here, who needs reconciling? The truth is that the world needs reconciling—the world needs to be reconciled to God. Okay, if God created the world out of chaos many millions of years ago, why can't he straighten it out today? Sure, that would be the simple way out of the mess we have made of things, and most of us would just like to sit back and let God do just that. But that's not the way God works—he depends upon us to clean up the mess that we humans have caused. And that's where the members of Affirmation come in. We have some of those special talents given to "queer" people just for this kind of job. It is a job for each one of us

regardless of our education, financial situation, success or lack of it. Of course, Affirmation has already started the reconciling process through the Reconciling Congregation Program, but more remains to be done. Is this *our* challenge from God? Evidently God likes to use the humble, the dispossessed, the outcasts of the world for his work. Homosexuals can probably be categorized in this way. This *is* our challenge—can we meet it? Can we suceed? Let's try! ∇

of the love of God in Jesus Christ to everyone.

Come home to our Christian calling: proclaiming good news to the poor, release to the captives, recovery of vision to those who do not see and freeedom to the oppressed.

Come home to the wisdom of our Wesleyan polity: evaluating pastors by gifts, grace and the fruits of their ministry.

Come home to evangelism.

Come home to mission.

Come home to grace.

Without grace, we won't span the chasms that rend our community. Without grace, we won't repair the rips in the fabric of our church. Without grace, our fragile human institutions will shatter, will rip to shreds. Without grace, our memories for hurt are too long, our suspicions too high, our demands too impossible.

Thank God, grace abounds, whether we deserve it or not. Grace can enable people who have labeled each other to welcome each other. Grace can clear our minds, so that we can see God at work in each other. Grace can transform our awkward attempts to mend the torn fabric into a beautiful embroidery of reconciliation.

Grace, and the love of God, turned the cross into an emblem of love.

Grace, and the love of Christ, turned the persecutor Saul into the evangelist Paul.

Grace, and the love of the Spirit, turned slave trader John Newton into the author of that hymn to Amazing Grace that we know so well.

Grace can heal our broken church.

Affirmation comes to General Conference proclaiming and celebrating the grace of God. We believe that our brothers and sisters

in Christ will respond to God's grace with warm hearts and open hands.

Alone, we could not persuade you to open the doors, embrace your sisters and brothers in the faith and stand together to counter oppression. But we are not alone.

Alone, we could not decide, all of us, to set aside our own painful histories and reach out to embrace and heal the wounds of our colleagues in the faith. But we are not alone.

Alone, we could not overcome our fears, let go of control, and step away from the wom pathways of judgment, bitterness and estrangement. But we are not alone.

We are caught, held, tumbled and wrapped in the grace and love of God, for whom nothing is impossible. In our lives, we know this. As deeply as we know anything at all, we know this. So we proclaim it, celebrate it and sing it out as our resolve and invitation:

"tis grace hath led [us] thus far, and grace will lead [us] home."

Brothers and sisters, let's go home.

A fund-raising letter was mailed to our entire mailing list in late January. All funds raised will be used for our presence at General Conference. Our only other obligations between now and the end of the fiscal year (5/30) are one more newsletter and recurring phone and other communication costs.
